Mr. Hanlin has prepared numerous business valuations since 1984. These valuations have been prepared for purposes of acquisition or sale of a business, for settlement in divorce proceedings, for partner/shareholder dispute resolution, for stock valuation in accord with specific terms of

buy/sell agreements, and estate/gift tax purposes. Mr. Hanlin has been called upon to review the valuation reports of other experts during litigation and mediation. In 1994 Mr. Hanlin completed a formal regimen of training in business valuations, attaining the designation as a Certified Valuation Analyst (CVA). He is presently the President & CEO of the International Association of Certified Valuation Specialists (IACVS). The mission of IACVS is to train and promote the worldwide uniform application of valuation theory and models. Mr. Hanlin has earned the prestigious credential ICVS (International Certified Valuation Specialist).
